## HOW MUCH DOES IT COST TO FORM AN LLC?



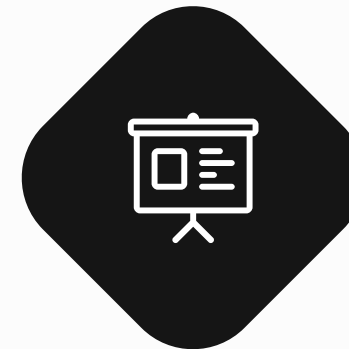

# Costi gestione LLC

Taxable Income (X)	Tax Rate	Tax Computation Formula
\$0–\$50,000	15%	$\$0 + 0.15X$
50,001–75,000	25%	$7,500 + 0.25(X - \$50,000)$
75,001–100,000	34%	$13,750 + 0.34(X - 75,000)$
100,001–335,000	34% + 5%	$22,250 + 0.39(X - 100,000)$
335,001–10,000,000	34%	$113,900 + 0.34(X - 335,000)$
10,000,001–15,000,000	35%	$3,400,000 + 0.35(X - 10,000,000)$
15,000,001–18,333,333	35% + 3%	$5,150,000 + 0.38(X - 15,000,000)$
18,333,334 and up	35%	$6,416,666 + 0.35(X - 18,333,333)$

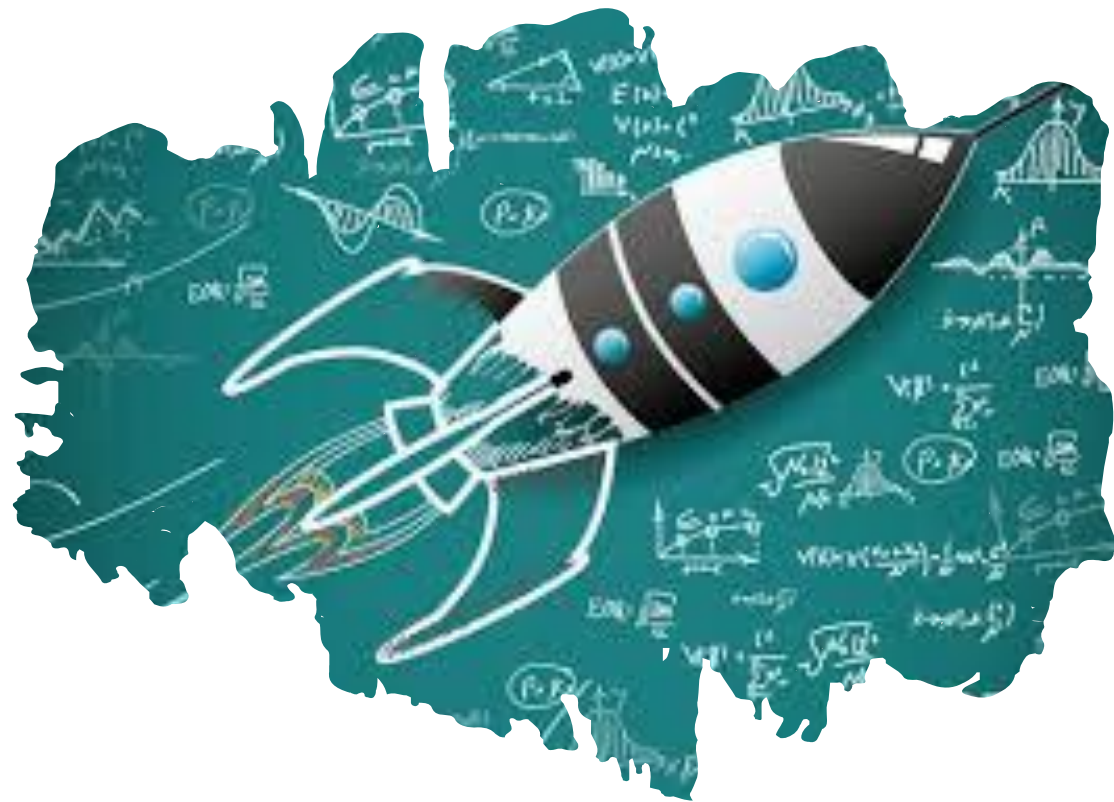

DOW JONES – FTSE MIB

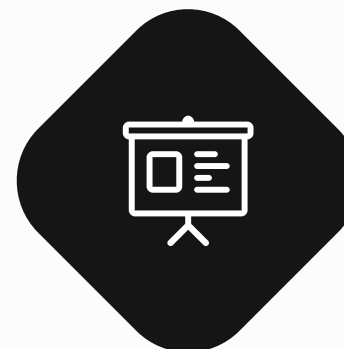

# Tassazione personale FL

## Individual Taxpayers

If Taxable Income Is Between:	The Tax Due Is:
0 - \$9,525	10% of taxable income
\$9,526 - \$38,700	\$952.50 + 12% of the amount over \$9,525
\$38,701 - \$82,500	\$4,453.50 + 22% of the amount over \$38,700
\$82,501 - \$157,500	\$14,089.50 + 24% of the amount over \$82,500
\$157,501 - \$200,000	\$32,089.50 + 32% of the amount over \$157,500
\$200,001 - \$500,000	\$45,689.50 + 35% of the amount over \$200,000
\$500,001 +	\$150,689.50 + 37% of the amount over \$500,000

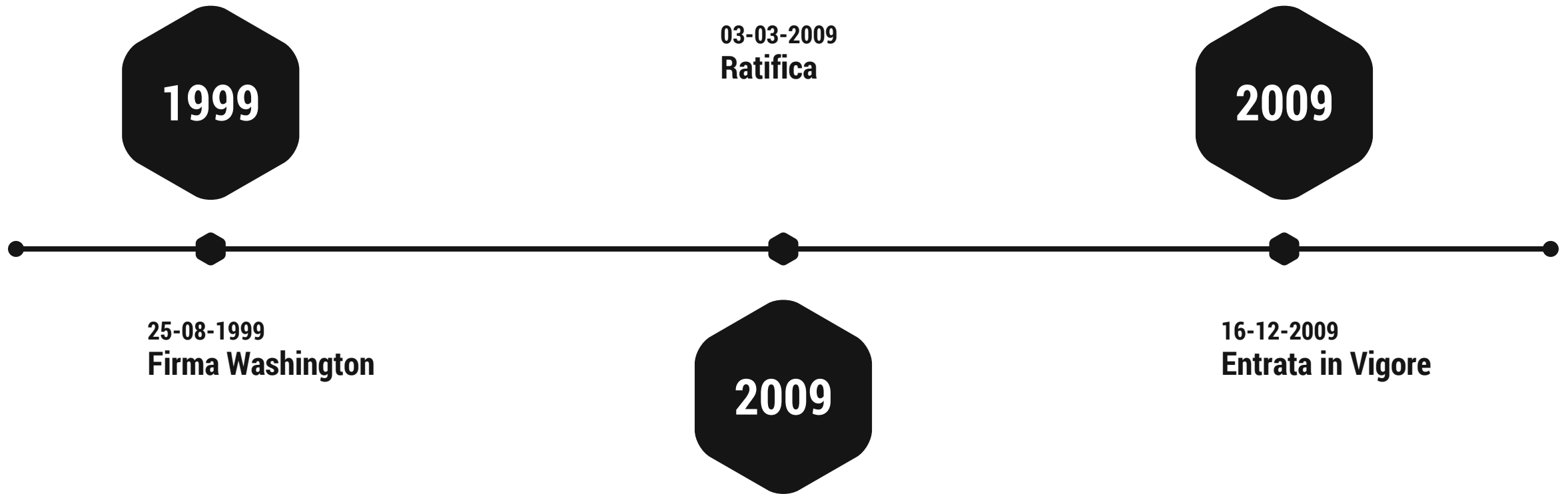
